WATERWORKS RATE POLICY

The Town Council in Hepburn has a policy of reviewing rates annually. Bylaw 58-2019 came into force on April 5, 2019 upon Provincial approval. This bylaw set the rates for the use and consumption of water and sewer as well as infrastructure fees.

The rates for access and consumption are as follows:

The objective of the Waterworks rate policy is to ensure the Town is covering the cost of regular increases from the service provider (SaskWater), and that these increases are passed on to the end user.

WATERWORKS CAPITAL INVESTMENT STRATEGY

To cover the costs of future waterworks infrastructure maintenance and replacement, Council will analyze revenues and expenses of utilities and will adjust rates as necessary to build the waterworks capital reserves. The capital investment strategy will ensure that safe drinking water can be provided to the residents, businesses, and surrounding rural community in the present and future.

Asset Management plans for both Water & Sewer were developed in 2017, to plan for replacement and repairs of water and sewer infrastructure. Future infrastructure upgrades will continue, such as sewer relining and lagoon upgrades.
